Whereas, in 1941 the United States of America was plunged into World War II; and many Cheatham County residents answered to call to defend the country against the enemies of Germany and Japan; and Whereas, four brothers of the Harrison and Della Perry family-Hugo Perry, Otto Perry, Woodrow Harrison Perry and Tildon Odell Perry all left their East Cheatham County home to serve our nation; and Whereas, Hugo Perry, at age 22, entered the service in December 1942, and obtained the rank of Private first Class as a member of an engineering unit that traveled overseas and on June 1, 1944, and died in combat at North Burma; and Whereas, Hugo's twin brother Otto Perry, at age 21, enlisted in October 1941, and was killed in battle on March 9, 1945, as Sergeant in the Pacific theatre of the war in the Philippines. Otto was a member of the famous Flying Squadron that crashed Japanese defenses to liberate the first civilian internees at Manila; and Whereas, Woodrow Harrison Perry, at age 24, entered service December 31, 1941 and continued through June 24, 1945. He obtained the rank of Master Sergeant in the US Army Air Forces, tail gunner on a B-25 with the 21st Bomber Group campaigns at Tunisia, Sicily, Naples, Arno, Southern France, Foggia, Rome, PO Valley and Northern Apennines. Woodrow earned the Bronze Star, Distinguished Unit Badge, Oak Leaf Cluster to Distinguished Unit Badge, Good Conduct Medal, Lapel Button issues and the EAMEOT Medal. Woodrow died on August 21, 1995; and Whereas, Tildon Odell Perry, at age 19, entered service on March 16, 1944, and as a Private First Class was injured in the battle of Belgium in October 1944. Tildon was awarded the Combat Infantry Badge, European, African, Middle Eastern Ribbons, The Good Conduct Medal and the Bronze Star. He died on February 16, 1984. Therefore, be it resolved, by the Cheatham County Mayor and Commission, to recognize the ultimate sacrifice and dedication of the Perry brothers and family.
